ParentVOICE - MHA provides information, support and opportunities that strengthen and inspire youth with mental health challenges, and their family/caregivers, to learn, lead, participate, and advocate for quality services and successful outcomes. This program is staffed by parents and caregivers of youth with emotional, behavioral and mental health concerns and provides trained and caring Family Support Specialists to help families navigate the education and mental health systems. The program also provides an opportunity for families to connect with other parents facing similar issues. Participating families learn to successfully navigate the mental health, educational, and juvenile justice systems; become empowered; and increase self advocacy skills.

4b (Code:) (Expenses \$ 282,951. including grants of \$) (Revenue \$ 8,000.)

Mental Health Advocacy and Education - promotes mental wellness through advocacy, prevention and education. Advocacy efforts help to achieve social or policy change by identifying and framing the issues related to mental health services delivery, developing alliances, and gathering and disseminating data. The program also provides information and referral, as well as the delivery of community education and trainings such as suicide prevention training.

Compeer - Compassionate volunteers are matched with persons diagnosed with severe and persistent mental illnesses for socialization and recreation. Compeer volunteers help reduce the loneliness and isolation that often accompany mental illness. Research shows that Compeer pairings often result in fewer hospitalizations, improved adherence with treatment programs and increased self-esteem for people with mental health concerns. Compeer matches help decrease overall medical costs because of the associated reduction in rates of recurrence.
