Rep. Cunningham Introduces Suicide Prevention Resolution in the North Carolina House of Representatives

On July 02, 2014, HR1262 (Suicide Prevention Resolution) passed through the House, moving on to the Senate! The Sponsor of the bill, Representative Carla Cunningham from Mecklenburg County, spoke to the House about the challenges she and her son have faced over the years as he struggled with a mental illness. Her story commanded the attention of everyone in the House Chamber. She also credited and expressed her appreciation to MHA for support and encouragement of her efforts to move forward with this Resolution. MHA applauds Representative Cunningham's achievement to develop legislation that may ultimately lead to a reduction in the suicide rates in N.C., particularly among our Youth and Veterans.
